With these investments, we are continuing to deliver on our commitment to replenish our development programme. In 2025, we now have already added a total of approx. €105 million in new development projects. Together with our Finnish Hoivatilat team, we look forward to continuing to design other new projects and adding them to our pipeline."

Atte Niittylä, CEO of Hoivatilat, adding: "Once completed, these care homes in Lappeenranta, Kokkola and Vihti will support the well-being of up to 152 elderly residents in total. Two of these three development projects are designed and developed in-house by our local Hoivatilat team. Special attention has been paid to environmental standards and energy efficiency in the design of these projects. Together we are creating a better society."

Aedifica will invest approx. €21 million in the development of three new care homes in Lappeenranta, Kokkola and Vihti.

Lappeenranta Tyysterniementie in Lappeenranta (73,000 inhabitants) and **Kokkola Kimalaisenpolku** in Kokkola (48,000 inhabitants) will accommodate up to 52 and 50 elderly people requiring continuous care, respectively. Both development projects are designed and developed inhouse by our local Hoivatilat team. Construction of both buildings has already started and is expected to be completed in the second quarter of 2026. The properties will be operated by **Mehiläinen**, an established private operator with broad experience in providing care and social services in Finland. Founded in 1909, its mission is to promote health and well-being by offering high-quality, comprehensive services. Mehiläinen operates a wide service network with over 840 units and already operates 20 Aedifica properties.

The **Vihti Puhurikuja** care home in Vihti (29,000 inhabitants) will also welcome up to 50 elderly people requiring continuous care. Construction started in May 2025 and is now halfway complete. Completion of the project is anticipated in the first quarter of 2026. The property will be operated by **Kaarikeskussäätiö**, a local non-profit foundation. With nearly 40 years' experience in care services, the foundation focuses on preserving independence and encouraging self-reliance to promote the well-being of the elderly.

All three care properties will be equipped with **sustainable energy systems**. Vihti Puhurikuja will utilise geothermal heating, while both Lappeenranta Tyysterniementie and Kokkola Kimalaisenpolku will feature a combination of geothermal heating and solar panels. This should result in excellent EPC⁴ ratings for each of these buildings, contributing to the continued improvement of the sustainability of the Group's real estate portfolio.
